Modular teaching is considered one of the promising systems of teaching, since it is best for the system of developing the student's cognitive capabilities and creative abilities moslashgandir.An ' in traditional education, educational goals are expressed through pedagogical activity, that is, they are oriented towards knowledge, while in modular teaching they are expressed through student activities and are oriented towards professional activities. When switching to modular training, the following are the objectives:

- ensuring continuity of teaching;
- individualization of teaching;
- creating sufficient conditions for independent assimilation of educational material;
- speeding up training;
- achieve effective mastery of science.
- The modular approach is based on consistent control of the achieved result. As a result, a modular-credit system has arisen.
- Credit-(ECTS-European Credit Transfer and Accumulating System)) is a cumulative system.
- The basis of the European credit system is three elements:
- weekly loading should not exceed 54 hours, 54 hours is equal to 1.5 credits. The duration of the school year is 40 weeks on average in Europe.
- The credit system includes control of all forms of training
- (except auditorium and auditorium).
- The credit system is a unit of measurement that indicates the achieved result, and not the amount of hours spent in the educational process. That is, it is the unit of measurement aimed at the result that evaluates a specialist to the level of competence.

So, a loan is not only an assessment of educational activities, but also a unit indicating the educational load performed. One credit is equivalent to 36 academic hours (54 academic hours are 1.5 credits).

At the stages of further development of the higher education system, special attention is paid to the module-credit system. The distance learning platform based on modular technology, which is part of modern information and Communication Technologies, is of great importance in the independent acquisition of knowledge by students. Students will have excellent access to the educational resources placed by a specialist in their subject to the modular distance learning platform. There will also be opportunities for knowledge control tasks and test questions, indicators of the student's use of the platform, existing problems and questions, feedback.

In the development of independent educational activities of students, it is necessary to introduce a system of organizational and methodological assistance "tyutorlik". In the tutoring system, the student is given knowledge, understanding and skills in the non-traditional period

of study. Tutoring can be organized in individual or collective forms.
