We have also seen that the rule that a husband and wife cannot abuse the rights arising from family relations in relation to each other is not expressed in the current code. In this regard, it is advisable to include in the Family Code a provision that spouses, including other family members, are obliged to abide by the law, respect the rules of joint marriage, moral principles, act in good faith and honestly in the exercise of their rights and obligations arising from family relations.
